2020 Fact Sheet – SATCOM Acceptance Testing

Background:	A 2019 and 2020 SATCOM Acceptance Testing supported by an experimentation campaign will allow for an established structure of acceptance testing criteria and tested capabilities in support of cross-DOTMLPFI requirements. This includes supporting the transition from the previous Materiel solution-focused process to new Capability Development processes and potential areas of future SATCOM capability development. Additionally, the experiment will make use of the DOTMLPFI requirements to explore potential solutions that may contribute to concept development and included in analysis of alternatives.
Mission:	Bi-SC Anti Jamming (AJ) Operational Life Test (OLT) Phase 3: Conduct a comprehensive OpEVAL across DOTMLPFI of Advanced Satcom Network Management and Control system (ASNMC) and Electromagnetic Spectrum (EMS) and validate status of SATCOM Capability.
Experiment Category:	Classic Experimentation
Milestones:	Phase 1 in January 2019 baselined the current configuration and performance, and Phase 2 September 2019 technically tested the distributed fully meshed network with simulated jamming threat. The final Phase 3 is delayed but now planned as a DOTMLPFI Tabletop Discussions and OpEVAL in Steadfast Cobalt at the end of September/October. This experiment will build from the previous events and examine the requirements from an operational perspective of a NATO Command Structure. This experiment will include a collaboration of diverse stakeholders that will explore SATCOM operational requirements and potential solutions to support development of the Future SATCOM Capability Concept.
