1. With Reference A, Allied Command Transformation (ACT) submitted a revised Capability Programme Plan (CPP) to North Atlantic Council for approval of a new capability, accordingly to the Common Funded Capability Delivery Model (Reference B). ACT is responsible for identifying alternative solutions and making an independent assessment, through the Analysis of Alternatives (AoA) process. The preferred alternative(s) will inform the development of a new sub-category for the capability, related to transmission means, its acquisition strategy, and an addendum to the CPP for a future decision by Nations.

2. In order to conduct an AoA, ACT requires detailed information. Therefore, ACT invites the Nations to complete an in-depth survey about deployable wireless transmission means suitable for performing Command and Control, which is described at the Enclosure 1. Initially, Nations and Industry were kindly requested to provide their responses to the Points of Contact by 29 October 2021. According to this corrigendum, the cut-off date is postponed to 30 November 2021.

3. National Authorities are welcome to forward ENCLOSURE 1 (Request for Information-RFI 21-101-CORR1) to designated industries. Enclosure 1 is also uploaded on <u>www.act.nato.int/contracting</u>.

4. National subject matter experts who provide potential alternatives for SOF C2 CIS additional transmission means may also be invited to engage and participate in a future virtual workshop to be held in December 2021 or January 2022 to further understand the solution(s) offered. An invitation will be sent accordingly by ACT development team.
