Requirement: HQ SACT is seeking contract support to enable HQ SACT timely access to leading-edge capabilities necessary to tackle challenges and problems whose size and complexity defy solutions by solely using existing staff or tools with NATO's established organization.

Type of Contract: Firm Fixed Price (FFP) Framework Contract

Period of Performance: 01 Jan 2026 – 31 Dec 2026 with the possibility of two 12- month option periods; 01 Jan – 31 Dec 2027, 01 Jan – 31 Dec 2028

Bidding Procedure: Best Value

Funding: Estimated cumulative annual amount, Min 2M EUR / Max 10M EUR

Classification: NATO UNCLASSIFIED

Issue Date: 4 Sept 25, (target date)

Bid Closing Date: 20 Oct 25, (target date)

Eligibility: Companies which have performed similar contracts within the last three years substantially similar in scope to the requirement described in the solicitation. Companies must hold a valid NATO or National Facilities Security Clearance (FSC) and be owned/headquartered in a NATO member nation.
